Beeston's, Andrewes' and Palyn's Charity, Peckham.

Managed by The Girdlers' Company.

Based at Consort Road, Peckham, the almshouses provide 18 flats for: Freemen of the City of London, people employed in trades similar to that of a Girdler, and persons resident in the former administrative county of London (as constituted on 31st March 1965). To find out more visit

Dulwich Almshouses, Dulwich.

Managed by Dulwich Almshouse Charity.

Based on College Road, Dulwich, the Grade II listed almshouse has 16 flats for older people in need, aged 60+, who have been living for at least the past 3 years in one of the former parishes (as constituted on 1st May 1891) of: St Botolph's Bishopsgate, St Luke's Old Street, St Saviour's

Edward Edwards' House, Bankside.

Managed by Southwark Charities.

Based on Nicholson Street, by Blackfriars Road, Edward Edwards' House will be redeveloped from 2024 to significantly increase the number of flats, to 62, available for older people in Southwark with a housing need in the latter part of this decade. Helen Peele Memorial Almshouses, Rotherhithe.

Hopton's, Bankside.

Managed by United St Saviour's Charity.

Completed in 1752, Hopton's is a Grade II* listed almshouse with 20 homes for Southwark older people aged 65 plus on low incomes and low savings. The historic nature of the buildings means that the flats are not generally suitable for those with serious mobility problems. Saint Mary Newington Close, Walworth.

Managed by Southwark Charities.

The Appleby Blue Almshouse, Bermondsey.

Managed by United St Saviour's Charity.

Opened in 2023, the 'Appleby Blue' almshouse on Southwark Park Road, managed by United St Saviour's Charity, comprises 57 affordable homes for Southwark's older people aged 65 plus on low incomes and with low savings. St Saviour's Court, Purley (LB Croydon).

Walters Close, Walworth.

Managed by The Trust Partnership on behalf of The Drapers' Company.
